IN ORDER FOR TVC TO FULFILL THEIR RESPONSIBILITIES TVC CREATED TWO INVESTMENT FUNDS WORKING CAPITAL FUND AND AN ENDOWMENT FUND. THESE FUNDS WERE PUT IN PLACE SO THAT WE CAN ENSURE TVC IS INVESTED FOR "IN PERPETUITY". AT THIS TIME OUR CONTRIBUTIONS ARE DWARFED BY OUR INVESTMENT REVENUE. THE MAJORITY OF THESE FUNDS CAME FROM MITIGATION REQUIREMENTS DUE TO PROGRAMS IN PLACE BY CITIES OF LIVERMORE AND PLEASANTON AND ALAMEDA COUNTY.
